Rooster Heaven Hunt Club Club Policies

1. We reserve the right to refuse service to anyone for any reason.
2. Pricing is subject to change without notice any time prior to reserving a hunt. Once reserved all pricing is honored and will not be changed. Payment for the shotgun and muzzleloader season is due at the time of your reservation and will be refunded if permits cannot be obtained for Livingston County.
3. A shotgun or muzzle-loading hunt is reserved when the hunter commits to sending a payment.
4. Unless otherwise agreed to by all parties, a payment shall be in full for the cost of any hunt.
5. The reservation will be held for a period of 30 days. If the payment is not made the "reserved" date will become open to other hunter reservations.
6. A hunt is not "booked" until a payment is received and clears the bank.
7. Once booked, the terms of a hunt are considered set in stone, unless all parties agree to any changes.
8. A payment may be made by check, cashier's check or money order, made out to; Rooster Heaven Hunt Club 26596 E 1000 N Rd. Forrest, IL 61741. Please include detailed information regarding the hunt such as dates and the hunters name so that the payment can be applied correctly. Your contact information should also be sent so a confirmation letter can be sent.
9. A payment is the hunter's assurance that they will make the hunt.
10. If a hunt is canceled by hunter(s), there will generally be no payment returned unless plenty of notice is given and all parties agree to any changes. Please understand, we don't want anyone to lose their money, but there are limited permits issued and hunting preserves available for shotgun and muzzle loading seasons. These reservations cannot be filled without Illinois shotgun permits which must be made at the beginning of each season.
11. If Rooster Heaven Hunt Club cancels the hunt, all moneys will be returned. To this date no hunts have been cancelled and this item has been added for the reassurance of the hunter.
12. We will not be responsible for moneys spent by hunter(s) for hunt preparation prior to our cancellation.
13. Hunters must furnish Illinois shotgun permits to Rooster Heaven Hunt Club for approval prior to entering any of our preserves to hunt game.

14. A hunter may harvest (if in possession of the required Illinois permits) one antlerless and one antler deer during the shotgun season. A harvest is any animal leaving blood, whether recovered or not; no exceptions to this policy. No more than one buck may be taken per year by a hunter.

15. While on the hunt, all participants are expected to act in a safe and sportsmanlike manner at all times. **All** Illinois State regulations must apply and will be strictly enforced by Rooster Heaven Hunt Club.

16. Anyone not acting in a safe and/or sportsmanlike manner in the opinion of any Rooster Heaven Hunt Club. Its representatives or staff members will be asked to leave the hunt club and no refund of any kind will be offered.

17. All hunting parties prior to entering the preserves at Rooster Heaven Hunt Club must sign a liability waiver.

Participant also agrees for himself/herself, his/her heirs, executors, administrators and assigns, that in the event any claims for personal injury, property damage or wrongful death shall be prosecuted against Patrick Harms, or Rooster Heaven Hunt Club or any of his agents, servants, employees and other persons connected with Patrick Harms, or Rooster Heaven Hunt Club for any act or acts of Participant, he/she shall indemnify and save them harmless from any and all said claims or causes of action by whomever or wherever made or presented.

Participant acknowledges having read the foregoing paragraphs, that he/she has been fully and completely advised of the potential dangers incidental to the hunting activities, and is fully aware of the legal consequences attendant to signing/executing the Consent and Release.
